



ARTISTREET Dance!

MyCreative Ventures Sdn. Bhd. (the “Organiser”) calls for all aspiring, enthusiastic Malaysian dancers to take part in ARTISTREET Dance! (the “Competition”). Top finalists will stand a chance to showcase their ultimate dancing skills at one of Malaysia’s biggest creative events happening this December* and stand a chance to win cash prize of up to RM18,000.

Fourth Place: RM1,000
Fifth Place: RM1,000

ELIGIBILITY

1. Any Malaysian with awesome dancing skills!
2. No age limit, however contestants below 18 years old must submit the Parents’/ Legal guardians’ Consent Form (“Consent Form”).
3. Acts can either be solo/ duo/ trio/ group with any combination of dance categories.
4. No restriction of the dance theme or genres. Contestants are free to create and break boundaries according to your imagination!
5. All performances shall exclude any elements of racism, politics, religion and any sensitive issues.

Terms and Conditions apply.

STRUCTURE

- Step 1: Record a video of your performance of not more than 5 minutes in length.
- Step 2: Submit the video together with the filled-up Registration Form and/or Consents Form (if necessary) to artistreet@mycreative.com.my. Both forms can be retrieved at www.mycreative.com.my.
Submission closing date is on 3 November 2019*.
- Step 3: Shortlisted contestants will have to perform at the Semi Final round tentatively in November in Kuala Lumpur at a venue to be decided by the Organiser*.
- Step 4: The chosen top finalists will then have to battle it out at one of Kuala Lumpur’s biggest arts event at a venue to be decided by the Organiser*.

*The Organiser reserves the right to change the date and/or venue of the event.

ENTRY PROCEDURES & CONDITIONS:

1. Contestant(s) must complete the Registration Form which can be downloaded from www.mycreative.com.my;
2. Contestant(s) must email the completed Registration Form together with photocopy(ies) of NRIC/ passport of all group members to artistreet@mycreative.com.my latest by **3 November 2019**. The subject of the email should be ARTISTREET Dance followed by the Contestant's / Stage Name;
3. The Registration Form shall include the following components:
 - a. Contestant (Solo / Duo/ Trio / Group) information; and
 - b. Performance details i.e. Title, and Category.
4. Contestant(s) are limited to one (1) submission;
5. Each registration will be acknowledged by an auto-receipt reply after it successfully reaches the Organiser's mailbox. If the Contestant(s) did not receive any reply within one (1) week of submission, kindly email us at artistreet@mycreative.com.my;
6. Contestant(s) that fails to comply with any of the procedures and conditions will be disqualified;
7. Shortlisted contestant(s) will be contacted to perform for Semi Final round on 28 November 2019 ("Semi Final"), after which, our panel of judges will select the top finalists to perform at the Final round for 2 subsequent days on 7 and 8 December 2019;
8. A briefing will be done by the Organiser prior to the Semi Final;
9. Winners will be announced on the second day of the Final round;
10. Contestant(s) should bring their own equipment or props and there are no limitation on props usage during the dance performance. However, Contestant(s) must comply with the Safety Code: No glass bangles, confetti or any other small/breakable objects, no smoke allowed on stage/backstage or in dressing rooms;
11. Duration of dance performance should be limited to a maximum of 10 minutes duration. The prescribed duration includes stage preparation before and after performance;
12. Contestant(s) under 18 years old must obtain permission from their parents or legal guardian prior to registration and must be accompanied by one of their parents or their legal guardian during Semi Final and/or Final rounds. The parent, or legal guardian must complete the attached Consent Form;
13. By submitting the Registration Form, it is understood that each applicant allows the Organiser, officers, staff, sponsors and affiliates to film video tape, and/or record the dancers, performance(s) and event participation for use in all forms of television, motion pictures, internet, social media, radio press releases, media, public relations, and other promotion/media formats.

SPECIAL TERMS AND CONDITIONS:

1. Contestant(s) must be free from any contractual obligations or arrangements or any other legal encumbrances, that may prevent him/her from participating in this Competition;
2. Where an original material is used or performed by the Contestant(s) during any stages of the Competition, the Contestant(s) must ensure and undertake that it does not infringe any intellectual property rights, ideas, or concepts of any third parties;
3. The choreograph routine and the song selection (if any) must avoid any elements of racism, politics, religion & any sensitive issues;
4. Where a Contestant(s) is selected as the Top Finalists of the Competition, one must be able to take time off from their daily activities, or employment, at any time during the Competition period, as may be requested by the Organiser at its sole discretion;
5. In the event the Contestant(s) decides to withdraw from the Competition at any time after being shortlisted, the Contestant(s) shall, on demand, reimburse the Organiser for all losses, costs and expenses incurred by the Organiser as a result of the Contestant(s)' withdrawal (including, without limitation, fully refunding any payments made by the Organiser to the Contestant(s)).

GENERAL TERMS AND CONDITIONS:

1. By entering this Competition, the Contestant(s) agrees to comply with Entry Procedures and Conditions, General Terms and Conditions, Special Terms and Conditions and Personal Data Protection Policy (collectively called "Terms and Conditions"). Non-compliance of these Terms and Conditions will result in disqualification from the Competition;
2. The Contestant(s) must adhere to the mechanism of the Competition as may be briefed and communicated to the Contestant(s) by the Organiser throughout the Competition;
3. By entering this Competition, Contestant(s) hereby warrant that all information submitted are true, current and complete. The Organiser reserves the right to verify the eligibility of all Contestant(s) and disqualify any contestants for submitting false information;
4. The Organiser reserves the right to review and approve all materials to be performed. Materials which include foul language, racial or religious overtones, or other sensitive topics/subjects deemed as inappropriate by the Organiser will not be allowed;
5. The Organiser reserves the right to cancel or amend the Competition's rules at its sole discretion without any prior notice. Any changes will be an amendment to the Terms and Conditions of the Competition;
6. The Organiser reserves the right to disqualify any Contestant(s) if it has reasonable grounds to believe that the Contestant(s) is not eligible or has otherwise breached any of the Terms and Conditions;
7. The Organiser reserves the right to request the Contestant(s) to change certain elements of the performance for the Competition as the Organiser deems fit;
8. The Organiser reserves the right to amend, postpone or reschedule the Competition period or any of the dates thereof at its sole discretion;
9. The Organiser reserves the right to showcase/publicise/disclose the videos/details included in the registration for any purposes deemed appropriate by the Organiser and the Organiser reserves the rights to brand, tag, mark, edit, modify, extract, impose any changes to the video as deemed appropriate for the abovementioned purpose; and
10. The Competition will be judged by a panel of professional judges on several aspect including enthusiasm, authenticity, coordination/synchronization, originality/innovation, creativity, song selection, steps/choreography/rhythm, costume.
11. In the event of any dispute regarding the rules, conduct, results and all other matters relating to the Competition, the decision of the Organiser shall be final and no correspondences, discussions and/or appeals will be entertained at any point of time throughout the Competition period.

ORGANIZER’S LIABILITY:

The Organiser will not be responsible or liable for:

1. Any problem, loss, injury, disappointment or damage of whatsoever nature suffered by any party due to any delay and/or failure in submitting the Registration Form throughout the Competition period;
2. Any problem, damage or loss of whatsoever nature to any Contestant(s), or their authorised representatives resulting from their participation in the Competition at any point of time throughout the Competition period;
3. Any compensation sought by third party as a result of copyrights infringement caused by any Contestant(s);
4. Any damage or loss of whatsoever nature to any Contestant(s)' music instruments, original materials, computer and/or electronic devices;
5. Any technical issues in relation to any telecommunications or internet network (including in relation to speed or bandwidth), including any injury or damage to Contestant(s)' or any other person's device related to or resulting from participation or downloading any materials in the Competition; and
6. Any other liabilities, actual or contingent that may arise from any other reasons and parties associated with this Competition and materials submitted.

 - b. Government authorities, agencies and and/or any other regulatory body, to the extent that the Government or other authorities, agencies and/or and other regulatory body need to know, or as permitted by applicable laws and regulations.

I/We further agree that in any event MyCreative receives any request by any data subject for withdrawal of consent to process any personal data provided herein, MyCreative has the right to treat this registration as null and void.
